## House Approves \$22 Million in Federal Transportation For Capital Circle NW

Leon County's top ranked federal funding request was approved by the House of Representatives, thanks to the strong backing of Congressmen Allen Boyd and Ander Crenshaw. The omnibus transportation funding bill earmarks \$22 million for the widening of Capital Circle NW from I-10 to West Tennessee Street (U.S. 90).

If approved by Congress, the funding will be used to improve traffic conditions and economic development along this key corridor. More than \$24 million in local

option sales tax funding, as part of the Blueprint 2000 program, has already been allocated for this critical intermodal project. This new federal funding, if approved by Congress, is anticipated to quicken the project's completion and also free up \$22 million in local funding to be spent on other priority Blueprint projects.

The next step for the Transportation Equity Act (TEA-21) Reauthorization bill is a conference committee where House and Senate members will craft a final version for full Congressional approval. It is anticipated that this bill will be considered by Congress before their July 4th recess.

The Leon County Board of County Commissioners extends its sincere appreciation to all members of the Leon County Congressional delegation, including Senators Bob Graham and Bill Nelson, for their continued support in fully funding this top Leon County road project.
