Abused and Neglected Children Need Your Help



In the spirit of National Child Abuse Prevention Month, Guardian ad Litem of the Big Bend is asking for volunteers to help represent the most vulnerable members of our community - our children. On any given day, there are approximately 1,000 abused and neglected children in the Second Judicial Circuit. Four hundred ninety-five of these children are right here in Leon County, and 127 children - most under 14 years of age - are alone in the court system. Guardian ad Litems are volunteers who represent abused and neglected children in court, social service agencies, and in the community. Anyone, ages 19 and up without felony charges or a history of child abuse or neglect, can be a Guardian ad Litem. On average,

Guardian ad Litems devote four to six hours a month, depending on the case. Volunteers must complete 30 hours of training before becoming a Guardian ad Litem. Training sessions occur every other month. The next training sessions begin on May 15. With the First Rate Increase in Ten Years, Waste Management, Inc. Fees Remain Competitive

Leon County is dedicated to providing the highest level of service to residents. In September 2006, the Board of County Commissioners approved the franchise extension agreement with Waste Management, Inc. for a six-year term, which included an increase in Waste Management, Inc.



collection fees. This increase will affect Leon County residents in the unincorporated area who subscribe to Waste Management, Inc. for curbside collection services, including garbage, yard waste, recycling, and bulky items. Because the agreement is effective April 22, 2007, quarterly bills are now reflecting the change.

As part of the franchise agreement, Waste Management, Inc. is able to increase fees for fuel adjustments or based on the Consumer Price Index (CPI). However, Waste Management, Inc. negotiated with the County to implement a larger collection fee increase for the year, which has not been done in more than ten years, to compensate for inflation. Future increases will be based on the CPI.

The increase equates to \$0.75 per year for the past ten years, and inflation and fuel adjustments were considered for the new rate. Residents in the unincorporated area who subscribe to the service will see a quarterly increase from \$31.59 to \$49.86. This fee breaks down to a monthly cost of \$16.62 – an increase from \$10.53.

The new fee is comparable to the City of Tallahassee's fee, which is \$14.39 per month. Differences between the unincorporated area of Leon County and the City of Tallahassee consist of higher density in the City, thus more efficiency in pick-up, and 25 percent more waste per household is generated by unincorporated Leon County residents. In comparison to the current market for other midsize Florida counties, this rate is competitive. Alachua County charges \$20.61; Lee County charges \$17.67; Escambia County charges \$16.80; Martin County charges \$14.88; and, Seminole County charges \$13.83.
