## Animal Control Ordinance Changes to Enforce the Humane Treatment of Animals

The Leon County Board of County Commissioners recently approved new rules regarding animal control that will provide for better protection of pets and the public.



The new ordinance addresses several

issues including new definitions, general enforcement and penalties, public nuisances, and rabies vaccination requirements. In addition, significant changes were implemented to address the humane care of animals, animals in motor vehicles, and the dangerous or aggressive animal classification process.

Pet owners who tether their dogs outside must use a properly fitting collar or harness and a chain that does not injure the animal. The chain must be a minimum of six feet long or three times the length of the dog as measured from the nose to the base of the tail, whichever is greater. Also, owners are not allowed to confine an animal to a vacant or abandoned structure, or leave an animal outside during a natural disaster.

Pet owners are no longer permitted to leave their pet unattended inside a motor vehicle where conditions, including heat or lack of water, could result in the suffering or death of an animal. Animal Control officers now have the right to take any necessary action to rescue the animal. Violation of these rules may result in a fine up to \$500.

Additionally, there are changes in how aggressive and dangerous animals are classified, allowing for the director of the Animal Control Division to make the initial determination. The owner's right to contest the classification, where to file an appeal, and how to conduct the hearing was streamlined to comply with recent court rulings.

#### Remember to File for Your Homestead Exemption: It's Like Money in Your Pocket!

If you have had any change in homeownership in the last year, make sure you have applied for Homestead Exemption by March 1. The Florida Constitution grants homeowners a \$25,000 exemption on the appraised

value of their home. This year, a full exemption is worth \$552 in tax savings. The County Property Appraiser's Office is accepting applications throughout February. Applicants need two forms of identification, such as a Florida driver's license, voter registration card, or vehicle tag number, and the Social Security numbers of all owners.
