#### Leon County Prepares for Possible Property Tax Reform Legislation



On-going property tax reform efforts in the Florida legislature could greatly impact local governments' revenue. Leon County is taking proactive steps to prepare for the possibility of reduced revenues, to avoid any interruption in essential services, and to protect current positions. The next 120 days will reveal what reform legislation will become law. At that point, the County will have

greater certainty and will be in a position to budget and resume operations accordingly.

On Tuesday, Feb. 27, the Board of County Commissioners endorsed the County Administrator's implementation of a hiring freeze for all personnel, with the exception of those that significantly impact the essential service level to Leon County citizens, such as paramedics, all travel which had not yet been approved, and a delay of capital projects which had not yet begun, such as community centers, branch libraries, greenways, and other projects.

#### Finding Mosquitoes Before They Find You



Throughout mosquito season, March through October, blueshirted Leon County Mosquito Control technicians work morning and night to control the County's mosquito population. Their quest: finding and fighting mosquitoes before they find you. This month, Leon County Mosquito Control is resuming their full service program of inspections, treatment

of breeding areas, spraying of adult mosquitoes, disease surveillance and helping residents to reduce the sources where mosquitoes live and reproduce.

Although mosquitoes are mainly an outdoor nuisance, some pose a more serious danger as transmitters of diseases including West Nile Virus, St. Louis Encephalitis or Eastern Equine Encephalitis.

Services such as hand-spraying yards and small properties, or truckspraying neighborhoods and large properties, are conducted at the request of residents. Homebuyer workshops will cover subjects such as assistance programs, how to become a homeowner, understanding


