Residents Urged to Vote on Proposed Admendments

In order to ensure that Leon County residents are aware of the six proposed Charter amendments that will appear on the Nov. 2, 2010, general election ballot, an informational booklet about the amendments has been created for the public. An electronic copy of the booklet is available on the Citizen Charter Review Committee website, www.leoncountyfl.gov/charter, and hard copies are available at many Leon County facilities, including the Main and branch libraries, the Renaissance Center and the Supervisor of Elections Office.

The booklet provides a brief summary of the six Charter amendments proposed by the Committee, so that citizens are able to make an informed decision when these amendments appear on the general election ballot. The material, which was developed for educational and informational purposes, is factually based and does not advocate for or against the passage of the proposed amendments.

Each of the six proposed Charter amendments are presented with the Charter amendment summary, which provides a brief overview of the proposed amendment; the ballot title; the ballot question, including language that will appear on the ballot for voter approval; and the full text of the proposed Charter amendment.

The Citizen Charter Review Committee, which was comprised of 15 Leon County residents, including one college student, were appointed by the Board of County Commissioners and charged with reviewing the County Charter and proposing any amendments or revisions for placement on the general election ballot in November 2010.

Throughout the entire charter review process, the Board and the Committee placed emphasis on public involvement. The Committee's website was designed to provide the public with all materials and information pertaining to the charter review process, including meeting agendas, meeting minutes and presentations. The website provided residents the ability to email any questions, concerns and comments to the Committee at 2010charter@leoncountyfl.gov.

Additionally, each meeting was broadcast live on the Committee's website and re-aired on Tuesdays on Comcast Channel 16. Several press releases were distributed to media partners to promote citizen participation and input.

Leon County will become one large book club October 9 through November 11, when the LeRoy Collins Leon County Public Library System hosts its second Big Read.

County residents are invited to come together to read, discuss and explore "The Things They Carried" by Tim O'Brien. The award-winning book is a tale of the Vietnam War and considered one of the finest books ever about combat. It is also is a brutal, sometimes funny, often profound narrative about the human heart how it fares under pressure, and what it can endure.

A limited number of free copies of the book will be available at the Kick-Off Celebration on Saturday, Oct. 9, from 11 a.m. to 1 p.m. in the Main Library Program Rooms. The library system

also has copies available for checkout, both individually and in book club kits.

The Tallahassee Film Society is partnering with the library again to bring a visual element to The Big Read. They will show "Coming Home" at 7 p.m. on Friday, Oct. 22, at All Saints Cinema.

On Wednesday, Nov. 3, Dr. Lance deHaven-Smith, a professor at Florida State University's Reubin O'D. Askew School of Public Administration and Policy and Vietnam veteran, will present the keynote for the Big Read. The Big Read will conclude with the Library's participation in the Veteran's Day parade.
