The legislation had nothing to do with written comments or anything else, including charrettes.

Not one Governor's Executive order has waived any requirements in the Sunshine Law (Chapter 286). Residents in Martin County, Miami-Dade County, Pasco County, Pinellas County, and many other counties have been able to speak and be heard during virtual meetings of their boards and commissions since March. Leon County residents have not. The 14th Amendment of the United States Constitution entitles to every person in every state the equal protection of the laws of that state. It's not right that some Floridians can be heard during county commission meetings while others cannot. The Leon County Board of County Commissioners needs to wake up, follow the law, and listen to the people.

Thank you for your assistance with the New Hope Cemetery Project in identifying this slave burial ground which has been abandoned, forgotten and built over. Many of our enslaved ancestors, great-grandparents and grandparents were born, worked died and are buried in the New Hope Cemetery upon these red clay hills of the Whitfield/Fleischmann/Welaunee Plantation.

The story is told that one of the Whitfield slaves was sent off to the Confederate Civil War with his sons to care for them if they were injured. It is told one was actually shot. His slave pulled the son out of the battle and stayed with him until he took his last breadth. The father was indebted to the slaves family for his bravery, and many are buried in this cemetery.

When freedom came, some slaves left, but others had no where to go, so they became tenant farmers on the plantation and were buried on this plantation in they worked until around the mid 1940's when no more burials were allowed. This project has been very spiritual wherein on our visits we could feel the presence.

There were many oral histories told of life on Welaunee. There were recollections when the Miccosukee and Centerville Road were trails, later to dirt roads and then finally to paved roads.

Other stories of how the Indians lived among the slaves on the countryside in Leon County. Brush arbor churches were built such as Indian Branch 1860(todays St. Peter PB Church Centerville Rd) and Testreena 1871 (todays Testerina PB Church Miccosukee Road).

We want our children and your children and generations to come, to know this story through educational site visits, dedicated memorials, stories and more. Let us recognize, care, honor, protect and preserve this historical site in memory of those who dedicated their service and life in shaping our community. Thank you.

I am an archaeologist with the National Park Service and have investigated a number of unmarked cemeteries, including the unmarked cemetery located at the Capital City Country Club golf course. The unmarked African American cemetery located on the Miccosukee Greenway and Testerina Primitive Baptist Church is not an isolated phenomenon. A 1999 state task force conservatively estimated that there could be as many as 1500 abandoned cemeteries across Florida. That vast majority of these cemeteries contain African American burials dating from the early 19th through the early 20th centuries that have been erased by development, displacement of black communities, and other factors. Because the area surrounding Tallahassee contained the bulk of Florida's antebellum plantation system, many of those abandoned African American cemeteries are located in Leon County.

Currently there are gaps in the Florida statutes that should be protecting abandoned cemeteries like this and while there are legislative efforts underway to try and address this issue, it has not happened yet. This is still a very real problem and many of these sites are in danger of being destroyed or have already been destroyed. Because of the wide scope of this problem and the lack of consistent guidance from the statutes it may be advisable for municipal governments like Leon County to take action through local ordinances or by developing a technical advisory committee or task force to address the issue. NPS is always available as a potential resource to provide technical assistance as needed.
