#### **GENERAL DESCRIPTION OF DUTIES:**

## <u>Salary will be commensurate to education and experience for exceptionally well qualified</u> candidates.

This position leads one of two major sections within the "Information Technology Section." The manager of the "Servers, Systems, and Security Group" supervises four IT professionals whose broad responsibilities include the operation, management, and maintenance of servers and infrastructure, physical and logical databases, major business systems, and disaster recovery. As a working manager, the incumbent in this position is expected to materially contribute to activities of the section while also undertaking strategic planning and actions to modernize core IT services. The incumbent also serves as LCSO's Information Security Manager (ISM) and is charged with leading the security program. This includes security monitoring, incident response, client training and education, continuity of operations planning, and interaction with other supporting entities.

#### **ESSENTIAL DUTIES:**

- 1. Assigns balanced workloads, ensures quality of work and that deadlines are met, and monitors productivity, attendance, and professionalism in the workplace.
- 2. Trains and mentors staff, sets challenging goals, delegates and coordinates effectively, promotes innovation in achieving goals; sets examples for subordinates.
- 3. Assists with budget management, proposal development/evaluation, and procurement.

- 4. Directs and assists in the installation, testing, implementation, and support of operating systems, applications, servers, and other products.
- 5. Conducts research, evaluation, and testing on emerging information technology solutions.
- 6. Ensures health and availability of infrastructure, servers, systems, and databases and through best practices in inventory, backup, patch management, endpoint security, and monitoring.
- 7. Serves as primary architect for current and future technical implementations.
- 8. Charts the organization's path to adopt cloud services.
- 9. Manages the IT security program.
- 10. Serves as the agency's Information Security Manager (ISM), ensuring security, compliance, and reporting to external entities as required.
- 11. Ensures that mission critical applications have appropriate high availability and resiliency locally.
- 12. Develops disaster recovery plans and conducts disaster recovery testing for mission critical systems.
- 13. Develops and refines policies and standards to support each work responsibility.
- 14. Plans, configures, and deploys new business systems.
- 15. Manages and maintain server and systems inventory.
- 16. Manages and maintain the virtual infrastructure, including ESX hosts and connected storage area network(s).
- 17. Manages and maintain Active Directory, Group Policy, and core network services (DNS, DHCP, WINS, NTP).
- 18. Supports routine audit and reporting requests.
- 19. Experience leading and managing teams, mentoring employees, and fostering collaboration.
- 20. Knowledge and expertise of servers, communication protocols, and network connectivity.
- 21. Knowledge and expertise in virtual infrastructure including VMware ESX and Microsoft Hyper-V.
- 22. Knowledge and expertise in Active Directory and Group Policy.
- 23. Knowledge and expertise in Cloud Services, including infrastructure-as-a-service offerings from AWS, Microsoft, and Google.
- 24. Knowledge of cyber security best practices and frameworks such as the National Institute of Standards and Technology (NIST) Cybersecurity Framework (CSF), Center for Internet Security Critical Security Controls (CIS), or similar.
- 25. Knowledge and expertise in continuity of operations planning (COOP) and Discovery Recovery (DR).
- 26. Experience managing an enterprise backup, replication, and recovery solutions Knowledge of basics of computer programming for business analytics and/or business intelligence software.
- 27. Strong organizational skills.
- 28. Ability to balance multiple priorities and quickly adjust to changing priorities.
- 29. Demonstrated ability to communicate effectively.
- 30. Strong ability to troubleshoot and resolve complex technical issues.
- 31. Ability to work closely with others as a team.
- 32. Ability to effectively communicate both orally and in writing.
- 33. Ability to provide professional customer service skills to both the public and agency members.
- 34. Ability to prepare and present clear, accurate, concise and objective written and oral reports.
