Each year they present an EMS Executive of the Year to an EMS manager whose performance matches the values and qualities deemed exceptional by the association.

Last year, Chief Quillin earned the Marilyn Crook EMS Pioneer award. The award is given to one individual statewide who has demonstrated extraordinary leadership and innovation and promotes best practices to build internal and external partnerships.

These awards are just a few of the many accolades recently given to the only 7-year-old EMS team. Last year, LCEMS was named the EMS Provider of the Year by the State of Florida.

LCEMS staff have also been recognized for their accreditation by the Commission on Accreditation of Ambulance Services (CAAS) for compliance with national standards of excellence. becoming the only municipal ambulance service to be accredited in the state and only the eighth municipal service accredited in the country.

Workshop Scheduled for New Public Safety Complex

Leon County and the City of Tallahassee will hold a workshop for any subcontractors who are interested in bidding on the new Leon County / City of Tallahassee Public Safety Complex. The meeting will be held at 5 p.m. on Thursday, Aug. 11, in the County Commission Chambers on the 5th floor of the Leon County Courthouse, 301 South Monroe Street. This event is free and no registration is required, but all subcontractors are required to complete the bidder prequalification questionnaire, which can be found online at www.ajaxbuilding.com/subcontractors_vendors.html .

Parking spaces are available in the paved parking lot located on the corner of Gadsden and Pensacola Streets, and street meter spaces will be available on a first-come, first-served basis. Additional parking is available in the Republic Parking Garage located on the corner of Calhoun Street and College Avenue. But please be advised that the garage closes at 7 p.m., and a parking fee will be required to exit.

The Public Safety Complex is a multi-purpose facility being developed in partnership between the City of Tallahassee and Leon County. When complete, the facility will house the City of Tallahassee Regional Transportation Management Center, the Leon County Emergency Operations Center, the joint dispatch center for Leon County and the City of Tallahassee and Leon County Emergency Medical Services, among others.

Leon County Reminds Residents About **Free Prescription Drug Discount Card**

With many residents looking for ways to save money on their prescription drug costs, the Leon County Board of County Commissioners is urging people to take advantage of its free prescription drug discount card program. The program, which is sponsored by the National Association of Counties (NACo), offers average savings of up to 24 percent off the retail price of commonly prescribed drugs.

The cards can be used by all county residents, regardless of age, income or existing health coverage. Many pharmacies will accept the NACo card, and a national network of more than 60,000 national participating retail pharmacies will also honor it. Best of all, there is no cost to County taxpayers for NACo and Leon County to make these money-saving cards available to Leon County residents.

In addition to these benefits for County residents, pet owners may also reap the benefits of the cards. If a pet has been prescribed a medication, owners may receive a discount on the medication by taking the prescription to a participating retail pharmacy.
