Dialing Leon County? Try Prefix 6-0-6



Leon County services are just a phone call away, but now that phone call begins with the prefix 6-0-6. Leon County replaced its decades-old telephone system with the new Avaya system. The system allows employees to receive faxes and voicemails via e-mail, to redirect calls to other phone lines, and to have caller-ID. Leon County Board departments and divisions, the

Public Defender, the State Attorney, and the Supervisor of Elections are on the new system and have the same prefix.

Since the 6-0-6 exchange is new to the area, some telephone users may have to program their phone systems to accept the change. For more information, please contact your telephone provider.

The old County numbers will remain online for the next several months. 'Tis the Season to Adopt-A-Tree

The Leon County Department of Public Works is proud to offer the 2006 Adopt-A-Tree public tree planting program. If you live inside Leon County, but outside of Tallahassee city limits, you may qualify for this program. By agreeing to water the tree three times a week for one year, Public Works will plant a White Oak tree anywhere between your house and any publicly maintained road or any privately maintained road with public access. To have a tree planted on your property between January and March 2006, simply fill out an application and place a wooden stake at the desired location. We will try to get as close to the designated area as possible.

The Leon County Board of County Commissioners will conduct a public hearing and hold a special meeting on Tuesday, Dec. 6, at 6 p.m., in the County Commission Chambers, 5th Floor of the Leon County Courthouse. The purpose of the meeting is to consider entering into a Chapter 163 Development Agreement for the Fallschase development located on Buck Lake Road, including frontage on Mahan Drive (U.S. Highway 90) and Upper Lake Lafayette.
