

#### County Nixes Business Tax

After hours of productive discussion last month, the Board of County Commissioners approved the proposed budget for the 2009/10 fiscal year that will reduce government spending by approximately \$19 million or 7.1% from the current year's budget.

Recognizing the economic downturn facing local industry, the Board eliminated the local business licensing tax. This \$25 County Occupational License is no longer required.

The County continues to maintain the lowest net budget, net budget per resident, the lowest number of employees, and the lowest number of employees per capita than other like-sized counties in Florida.


