Leon County Introduces Jackson View Park

Amidst the sounds of laughing and playing children, the Leon County Board of County Commissioners hosted a grand opening for Jackson View Park and its new playground equipment last month.

Leon County's newest park is located at 2585 Clara Kee Blvd., off of North Monroe St., just north of Perkins Road. Citizens from all over the County can come and take a stroll along the mile-long, looping walking trail, take in the lovely view of Lake Jackson from the observation pier, or enjoy an outdoor meal at one of the 12 covered picnic tables scattered throughout the beautifully landscaped park.

The playground equipment, designed for children ages five to 12 years old, is comprised of a swing set, climbers, slides, activity stations and more. Both the walking trail and the rubber surface of the playground are handicap accessible.

If you work well under pressure, have good interpersonal skills and like working with people, we need you. There are two ways to become involved:

Citizens Information Line

Volunteers ensure that the most current information is always available to residents. Staffing the Citizens Information Line includes responding to questions from the public via telephone, alerting the Public Information Office of any rumors or misinformation and trends in calls, and working closely with VolunteerLEON to assure that all community needs are routed to the appropriate individuals.

Volunteer Reception Center

Staffing the Reception Center includes processing applications, interviewing potential volunteers, matching individuals with requests from Leon County, the American Red Cross, and nonprofit organizations who need help following a disaster.

Get Paid and Gain Experience with the Summer Youth Training Program

Summer is a time when most students look forward to enjoying a vacation, but for some, summer is a good time to explore career opportunities. The Leon County Summer Youth Training Program is designed to allow students to do just that. This six-week program introduces participants to the workplace, imparts valuable employment skills, and provides a summer income for Leon County youth between the ages of 14 and 21.



This year, there are 65 positions available. All positions are for 20 to 25 hours per week and will pay \$6.79 per hour. Summer youth workers have the opportunity to gain experience in a variety of locations throughout Leon County, including Public Works, EMS, Parks & Recreation and several others. Students may apply for a maximum of two jobs. The 2008 Summer Youth Training Program is scheduled to run from Monday, June 16, through Friday, July 25. Applications are due Friday, May 9.
