Leon County's Apalachee Regional Park Trail will serve as host site to two major athletic events during November.

Leon County is proud to offer the **2013 Adopt-A-Tree** public tree planting program. If you live inside Leon County, but outside of Tallahassee city limits, you may qualify to have a Southern Magnolia "Little Gem" planted on your property for free. The Southern Magnolia "Little Gem" is a variety that is known for small stature and early blooming.

If you agree to water the tree three times a week for one year, Leon County Public Works will plant the tree anywhere between your house and any publicly-maintained road or any privatelymaintained road with public access. To have a tree planted on your property between February and March 2013, simply fill out an application online at www.LeonCountyFL.gov/AdoptATree or mail in the application below and place a wooden stake at the desired location. Public Works will try to get as close to the designated area as possible. One tree per household per year will be planted.

The application deadline is **Thursday, January 31, 2013**.
