Currently, Leon County has an overall 2.4% positivity rate with over 18,000 people tested. From what I can tell there have been five new hospitalizations over a greater than two week period (I don't have my County reports with me now-we were on 33 hospitalizations for a long time I do recall). Yes, the county had a few days with spikes of high numbers on very large data dump dates but those days are usually surrounded by low numbers. For disclosure purposes, I sit on the Board of Chaires-Capitola Little League and have been involved in the league over the past 5 years. Chaires-Capitola Little League is an important part of our community, we have hundreds of kids and families that rely on the Board to provide a safe environment for our players. The Board has and will always continue to ensure safety is our number one priority on and off the ball field.

On May 22 the Governor issued the Organized Youth Activities Executive Order, which indicated organized youth activities may operate, including youth sports teams and leagues, youth clubs and programs, and child care. Summer camps and youth recreation camps may operate including, but not limited to, those defined 409.175 and 513.02, Florida Statutes, respectively, we thought we were only days away from playing ball again. Unfortunately 3 weeks have passed and the County has yet to allow our children to play baseball.

Whether it is known or unknown to the County, many other youth baseball teams in the City of Tallahassee and Leon County not affiliated with Chaires-Capitola have already commenced adhering to the Governor's Executive Order. It's Now time for the County to allow our kids to play baseball again. In addition, countless counties throughout Florida have opened up youth sports and are hosting weekend long tournaments. Leon County should be doing the same. It's time to open up Youth Sporting Activities in Leon County.
