I implore you to consider doing away with the mandatory mask ordinance, and leave it up to citizens to protect themselves how they see fit. You have 1 in 67 chance of death from accidental poisoning by exposure to a noxious substance. 1 in 71 chance of dying of drug poisoning. 1 in 541 chance of dying as a pedestrian. 1 in 106 chance of dying in a car accident. With all of that said you may be asking yourself, why do all these statistics matter? Good question. As we go about our lives everyone of use takes on a certain level of risk. Though these risks are all around us each and every day this does not give the government the right to “mandate” unnecessary or unwanted rules or regulations without the consent of the people and not allow us the opportunity “to petition the Government for a redress of grievances.”

During the previous Leon County Commissioner meeting, not one person outside of the commission was given an opportunity to voice their opinion, present data, or express any grievance with the local government’s decision to mandate masks. We now face yet another meeting where the people are not allowed to be present to voice any concerns. The only venue for allowing one’s voice to be heard is to submit their apprehensions via a website for “review” prior to said meeting. These comments can easily be silence and/or censored infringing yet again on our constitutional rights.

With that said I am submitting my concerns in the hope that the voice of the people will not fall on deaf ears and each person’s concerns will be heard and elevated without censorship.

As the Leon County Commissioners decide further action regarding the mask mandate please considering the following:

- 1) Most people do not wear, clean, or dispose of masks properly potentially increasing risk to themselves, others, and the environment.
- 2) Wearing masks can give people a false sense of security. In addition, it often makes it hard to hear the wearer. This will cause people to be in closer contact than necessary.
- 3) “Face masks restrict the elimination of the virus, recirculating the virus into the nasal/sinus and upper respiratory passages” and potentially causing worse reactions.
- 4) Wearing masks increases the desire to touch one’s face and can potentially reduce people’s adherence to other important hygiene protocol.
- 5) Along with lock downs, mask mandates are unconstitutional. Requiring churches to worship or gather in certain ways instituted by the government is actively undermining first amendment rights of your constituents.

I'm the parent of a runner on a LCS Cross Country team.

I'm not a scientist, but I've been to a lot of cross country races both as a parent and athlete. Cross Country gives both athletes and spectators the greatest opportunity for social distancing. High School Cross Country courses are 3.1 miles long - which affords spectators and athletes a lot of room to spread out quite a bit during the event. It would be very unusual for a runner to be within "close contact (6') for a prolonged period" of another runner during a race. And there is no reason why spectators would need to be within close contact at all.

The psychological toll on these student athletes to not be allowed to compete at their sport is real and heavy. This is clearly not a contact sport.

In Leon County, Cross Country races traditionally occur in county parks.

Please allow Leon County Parks to be opened to high school cross county races. These athletes and the spectators at these events can be trusted to behave responsibly and safely.

I am going to address two issues I have not seen addressed adequately in other comment letters I have seen circulated. First, and by far most importantly, is the issue of equity for all youth. In my opinion, the most important reason for why we MUST reopen ARP for middle and high school XC meets is that the individuals most affected by this are our most at-risk youth – the ones whose parents cannot afford them opportunities outside of what is offered through public opportunities. One of the foundational principles of public school education and athletics is equal opportunity for all. This principle is largely the purpose of public education and many aspects of government in general. In Leon County, we are blessed with one of the most diverse populations in the state. When I attend cross country meets, I am excited to see that all the Middle Schools in Tallahassee field full teams, including many kids from less-privileged families. Without the possibility of public school cross country competition, these kids are left out, and this can have horrendous long-term consequences for kids where running is an outlet to better physical and mental health. With the LCSB moratorium on out of county meets and the county/city lockdowns on facilities, cross country has been singled out despite being arguably the safest sport. Most children of financially sound families have been competing (and will continue to compete regardless, because they can afford to do so). As a champion of running as an outstanding outlet for both exercise and mental release, I am sad to see the poorer kids in Tallahassee who love to run completely left out, and honestly to the detriment of their health, not protection. The scientific safety of running (and most non-contact outdoor activities) during the pandemic is well documented. All the cross country athletes from the underprivileged areas of Tallahassee will fall farther behind, and this honestly breaks my heart because I’ve watched the joy on the middle school runners’ faces as they experience the accomplishment of finishing a cross country race. My kids will continue to experience this joy regardless of what the county does, but the same is not true for less fortunate kids who are relying on public opportunities.

Second, I am confused by the rationale behind restriction a. in Option #2. Why include a restriction that says, “Prohibit spectators and nonessential personnel at cross country races”? I have tried hard to understand the scientific rationale behind this, but I can’t find any. I watched the FSU football game on TV this past weekend shortly after reading the county proposal for cross country, and I saw 17,000 fans packed together, drinking beer, and practicing no social distancing right here in Leon County. Jam-packed restaurants are open, and bars just opened throughout the state on Monday. Yet it is somehow unsafe for a few hundred spectators to watch a race outside, with masks, in a 52 acre park? Wearing masks, keeping adequate distance from each other, and staggering race starts are all very smart rules, and I see a very high degree of compliance at the meets I’ve gone to. Cross country runners and parents are a disciplined group who understand safety and rules. Most importantly, I have never seen a single documented case of COVID spreading on a trail, running, or watching a race. The science of the virus and empirical observation indicate that it would be safer to watch two dozen cross country meets than go one time to a restaurant. Yet somehow, bars and restaurants are open, yet the county is listing “no spectators” as a reasonable restriction to have at cross country meets. I strongly suggest the county remove restriction a. from Option #2 because it is completely inconsistent with the rest of the state, all other restrictions within the county, and frankly there is just no scientific reason to include it.

I am the Association Cheer and Dance Commissioner and Head Cheer Coach for Woodville Jaguars Pop Warner; the largest association in the Big Bend Pop Warner league. With regard to re-opening county parks for youth sports, staff recommends that high-contact, team-based sports like football and baseball do not support the reopening of county parks as these sports were deemed to have elevated or high risks associated with COVID-19. Staff then further recommends that cheerleading, which is organized by Pop Warner in the county, although among the lowest risk sports as outlined in their own background research, also not be authorized as “cheerleading is associated with supporting (cheering on) youth football”. This recommendation is wholly dismissive and insulting as it relates to an entire group of athletes who are proud to dedicate themselves to a SPORT that showcases their athletic and scholastic abilities as equally as others. It is also erroneous to insinuate that cheerleaders exist solely for the benefit of the football team through this recommendation.

Over the last decade, more recognition has been placed on cheerleading as the sport that is and its participants as the athletes they are. So much so, that cheerleading has been recognized by the Olympic Committee as a sport and is set to make its debut at the 2024 Olympics. Pop Warner has always recognized cheerleading as a separate program from football, but it has recently affirmed this by making cheerleading a year-round activity within the program. During the year, cheerleaders act as ambassadors for the entire program and compete in several competitions that lead to year-end competitions that equate to the Super Bowl. The global pandemic changed how cheer programs facilitated these activities. Per staff’s research, cheerleading (classified as a non-contact sport) modeled its high modification potential to mitigate the low risks associated with the sport by adapting in-person competitions to virtual, developing and implementing procedures to prevent the transmission of COVID-19 during cheer practices and created or modified competition categories that took into consideration social distancing guidelines like non-stunting divisions. Consequently, there have been no reports of spread events within the industry as most have resumed practices to some degree since the COVID-19 restrictions across the country have slowly been relaxed.

Staff’s background research thoroughly supports that cheerleading could begin practices at county parks due to the lower risks associated with the spread of COVID-19. Staff also lays out detailed recommendations for opening county parks for the purposes of cross-country racing; an activity that has similar risk levels as cheerleading. So, staff shows its willingness to allow certain sports activities with certain precautions and guidelines in place. Big Bend Pop Warner Cheer and Football programs are required to abide by the Return To Play guidelines established by Pop Warner Nationals not to supersede any local, state or federal mandates. Other Pop Warner Associations around the Leon county area have safely started their seasons under these guidelines. We are confident BBPW can do the same. However, what is problematic is with cheerleading being a primarily female dominated sport, staff’s recommendation to not authorize cheerleading at because football is higher risk is illogical and sends a message that cheerleading is only validated by football or other primarily male dominated sports.

We must learn to adapt to this new normal, keep ourselves and others safe but also live our lives. We cannot do that in fear or isolation. Therefore, I respectfully ask that the Commission wholly reject Option #1 of staff’s recommendation and reopen county parks and facilities by expanding Option #2 to include cheerleading and other sports with appropriate precautions as defined by each league’s return to play protocols.

Board of Leon County Commissioners,

During this ever changing time I hope we all can take a deep breath and lower the stress for a minute. My name is Ted DeVos, I am the head cross country coach at Nease High School. As an outdoor enthusiast, cross country coach and rational human I would request you strongly consider all of the opportunities presented by reopening Apalachee Regional Park. While I urge you to weigh all of the opportunities I am not requesting you to myopically open the park in light of risks. Rather I would ask you to weigh the benefits versus the costs with objective data and rational thought.

Please look at the document from Vincent Long to the Honorable Chairman and Members of the Board regarding agenda item #21. This document articulates objective data from credible sources regarding the risk, or lack thereof, for outdoor non-contact sports. The documents even confirm several methods of mitigation if necessary, such as eliminating spectators. However, the document leaves out one significant difference of cross country from all other sports.

Sports such as football, volleyball, wrestling, and soccer have a competitive objective in most plays to be as close to your opponent and create contact with them frequently. Cross country is the only sport where the goal is to get as far away from your opponent as possible. Not only do you want to get as far away as possible, you want to get as far away from the competition as quickly as possible. Extreme social distancing is the objective of cross country. Before and after each race it is very easy for teams to follow stated distancing guidelines and rules. During this time, we should be encouraging cross country as it's the safest possible opportunity for kids to participate in high level competitions. Cross country allows kids to have the highest level of benefits associated with athletics and lowest possible risk.

Leon county has created a jewel of a park in Apalachee Regional Park through their deliberate rational investment. I would urge the board to find a way to hold cross country meets including schools outside of the immediate surrounding counties even if restrictions on spectators are necessary. Cancelling meets will allow another course to host the pre-state meet and potential future meets at less desirable locations creating lower quality experiences. Losing the meet this year may have an impact for years, maybe even a decade or more. Tallahassee should be receiving the benefits, socially and economically, from their financial and social investments from creating a world class facility.

After objectively looking at the data and rationally considering the options I would hope the board concludes the best option for participants, spectators, Tallahassee and schools is option #1. Option #1 would be most in-line with the FHSAA fall sports approval which allows significantly even riskier sports to move forward. While option #2 is more restrictive it still allows opportunities to be seized. Successfully approving the hosting of meets at Apalachee Regional Park takes advantage of significant opportunities for everyone involved.

I hope this message finds you well. My name is Annabel Diaz, I am the mother of a XC senior and junior at Belen Jesuit High School now in the midst of our school season. I would like to urge you to consider opening your high school athletic competitions to outside teams such as ours. The highlights of our season for so many years now always include racing at Apalachee Regional Park. As a top national running program, we race at many venues throughout the state and around the country and truth be told there is no venue like yours. I can't think of a better venue right now during these times to more safely compete at than yours. The amount of careful investment in that Leon County property has led to the creation of a magnificent cross country race venue and it deserves to be constantly showcased. It is truly special and one of a kind for the youth running community. I am concerned that if there is a temporary restriction for using the Apalachee Cross Country venue this Fall that a long term agreement may be struck by the FHSAA with an alternative venue possibly more central to the rest of Florida. There are several options being floated out there that include some viable private venues. In other words, not having the FHSAA State Meet at Apalachee in 2020 could result in losing it for a long time.

We have been training and racing now for nearly a month and our program has had zero cases. I believe that is due to the internal safety measures we have taken, the parks we race in have taken and the race organizers have implemented as well. I am sure that Leon County together with the Cross Country can do the same. Our large team has traveled now to compete to three different counties in Florida. When we travel we normally book over 50 room nights and in November that number swells to over 60 nights. When we travel to these Counties all the way from Miami we positively impact the respective local economy. I look forward to doing the same for Leon County for the Prestate meet in October and then again in November for the FHSAA State Meet. One last thing to keep in mind is that many schools in the Leon County area are already traveling outside Leon County to compete as "Club" teams. This creates a reverse economic impact and frankly negates the possible objective of limiting teams from other Counties to visit Leon County.

I strongly urge you to consider allowing high school cross country teams from outside of Leon County to compete at your public venues, especially at Apalachee Regional Park.

According to the #21 Agenda Item, based on National survey results, 82% of outdoor sports fields are fully open. In Florida, the four counties studied are all open. Locally, Wakulla County has resumed organized sports. Travel ball leagues have been playing ball since the Governor opened up in late May in counties all over the State and surrounding States. I am writing to implore Leon County to opening up county parks for organized outdoor sports and athletics.

First, from a defensible position standpoint, if you do a survey around the state, the vast majority of counties have reopened facilities for outdoor sports use.

Second, the sport I am especially knowledgeable about and concerned about is cross country. All around the state races are being hosted, practices are resuming and meets/games are being held consistent with FHSAA's recommendations on how to carry out cross country meets safely and consistent with FHSAA's Sports Medicine Advisory Counsel ("SMAC") recommendations. I personally have been to two out of county meets, one in Tampa and one in Ocala, and saw first hand how the races can be successfully run. I have been monitoring county statuses across the state on reopening facilities for similar uses and we stand in a significant minority. I have also monitored any COVID related impacts from hosting XC races and have heard no issues in spread. Third, FHSAA put out a recommended waiver that the County could use for participation in such events, recognizing participation is 100% voluntary and with parent engagement.

Fourth, the SMAC report, comprised of Mayo clinic doctors and other medical professionals, concluded that cross country a low risk sport and could resume safely, with certain parameters in place.

Fifth, the school district is currently prohibiting our runners (and swimmers) to leave the County for races but with the county and city facilities closed, our runners have no where to race. Meanwhile, football will proceed WITH FANS, on our school campuses but non football athletes of swimming and cross country are in purgatory, stuck between mandated county races and no where to race in county. The only option to race, then, is to do so as an unattached athlete and travel the state.

Sixth, these kids and their parents are hungry for an opportunity to race. They have already had their track season cancelled, many are mentally struggling with school changes and stress, leaving options for college scholarships few and far between with sports because while the REST OF THE STATE races, our kids are stuck, not having a chance to obtain times makes college recruiting nearly impossible in this short season. If our kids can't compete, particularly against the other top runners in the state, their opportunities, and potentially their college and life trajectories, are irreparably changed.

Finally, to reiterate, the SMAC report from FHSAA acknowledged the low risks associated with cross country. These kids have been running together all summer with NO incident. Even when a couple of athletes on various teams were COVID positive, having contracted it through work or family in the cases of which I am aware, it did NOT spread to other teammates. We have several months of data now available to us – this is not a high risk sport. Please consider allowing the Leon County HS cross country runners to host races at County facilities. I am writing to you as a parent of a cross country/track/swim athlete. We find ourselves in an untenable situation. My son is one of several hundred cross country athletes in the county and one of several hundred swimmers, each with no facility access. These kids have put years of work, time, set lofty goals that are significantly impaired right now by COVID, yes, and by living in Leon County. I collected data and information on Florida's 67 other counties and what they are doing with HS sports. I am hopeful that through collaboration, reliable data and science there may be a reasonable conclusion to reopen facilities to allow our athletes to compete locally, or alternatively for our representative governments to work together to allow our athletes to travel outside of the County to compete at other facilities that are currently hosting meets. There are several "best practices" proposed by the FHSAA medical advisory Board, by facilities that have successfully hosted meets in the state without issue, etc, that the County (and/or City) could implement and I am happy to be part of a solution, including showing waivers we have used at other facilities, to mitigate any perceived risk. If there is anything I can do to help find a way forward, I stand ready as a citizen of Leon County. I appreciate all the hard work you all have at the present and ahead of you - this in no way minimizes the recognition of those efforts. I hope the County will, if time and energy strapped as I can imagine, look to a group of us that have a keen interest, significant background in sports, and a willingness to dig in to help figure out a reasonable, fact based solution while not dominating your staff's time and efforts. For your reference, I am also including the communication I sent to the school district on the same issue: I am writing to implore Leon County schools to consider allowing at least select sports with special considerations to travel out of the County, with restrictions (i.e. limit overnights, travel only with parents, use of masks, etc), and sooner than September 18. I compiled a list of counties and their FHSAA declared status. If you look around the state, the vast majority of schools are resuming practices and meets/games consistent with FHSAA's 8/24 and 9/4 provision for return to practice and meets/games, respectively. Further, even those few school districts that have put a limit on out of County travel have made provision for individual sports or sports that lack local facilities to participate to leave the county. For example, cross country is an individual sport. There are several impacts to our runners with the current restrictions: a. Runners are far more successful running against other athletes their speed or faster to excel. Club race categories are not competitive, if they exist at all – they exist at this moment until schools resume HS status and can start competing with their schools on 9/4/20. Thereafter, it is VERY difficult to find a high school club in state race; b. Limiting travel even after that date to in the county is problematic because the trail facilities are not available for races; c. Cross country has a short window to run times and make college recruiting (fall only). d. Even the medical advisory report from FHSAA acknowledged the low risks associated with cross country. These kids have been running together all summer with NO incident. Even when a couple of athletes on various teams were COVID positive, having contracted it through work or family in the cases of which I am aware, it did NOT spread to other teammates. We have several months of data now available to us – this is not a high risk sport; e. Leon County positive rate is now under 5%, lower than even the very conservative SMAC recommendation for full return to ALL sports, which was 5% even for football travel – and is well below the 10% recommendation from the WHO.

After reviewing Agenda Item 21 regarding the reopening of parks, including the ARP, for use for cross country meets and practices, I strongly urge the Commission to vote to reopen.

As the parent of a high school cross country runner, I think it is important that our kids have the opportunity to compete in their sport this fall. For the seniors, this is their last opportunity to be noticed by colleges or to run with their team.

It was noted several times in Item 21 that there are concerns that cross country might be a sport that is higher risk of transmission of COVID-19. While the CDC guidance certainly hypothesizes that, that is all that it is, a hypothesis. In reality, if there is a sport that is designed with social distancing in mind, it is cross country. The courses themselves are spread out over hundreds of acres or more, leaving plenty of room for spectators to spread out. During a meet, the runners generally do not run right on top of each other.

As of this comment, there have been approximately 21 cross country meets completed in the state of Florida since the beginning of August, including one in Tallahassee September 5. With 21 meets completed, there has not been one news report of an outbreak related to transmission in-competition or among spectators; had there been an outbreak, it would have been covered extensively on any number of news reports and websites.

I strongly urge the Commission to reopen parks for cross country practice and competition. I urge the Commission to do so with spectators being allowed at meets as well. Currently, the FHSAA has the State Meet scheduled for November at the ARP, and while it is noted in Item 21 that parents could "drop their runner off" and then go enjoy our area, the fact of the matter is a senior parent from the Tampa area is not going to accept that they paid for a hotel room but cannot support their child in what is likely their last competition. That is unreasonable. I will also point to an incident at the opening meet of the middle school season in 2018 at the ARP where the girls race was just about completed when a nasty thunderstorm tore through the area, leaving runners and parents alike scrambling to get to their vehicles; if parents are forced to drop off their runner and leave the area, who is then responsible for their safety if a similar situation occurs?

Upon reopening, it would of course be wise to do so with COVID-related safety measures in place, such as the recommendation that spectators wear a mask and social distance.

Good evening,

I am writing as a parent of an athlete who is eager to return to sports in Leon County. Our kids are in multiple sports and we have resumed traveling with various clubs to facilities in Orlando, Ocala, Gainesville, Jacksonville, Fort Myers and other areas and they are all opened with some COVID-related best practices in place. We would much rather be here locally, not having to travel all across the state, and seeing some of the income from these events coming to the Tallahassee market. I am not advocating for carte blanche reopening so to speak - rather, for sports like cross country, I have personally witnessed successful races where:

- spectators were temperature checked on the way in and required to wear masks if they could not be at least 6' away from others.
- athletes warmed up only with their teammates
- races were set up with wide starting boxes and not allowed to congregate in those boxes until just before the race start.
- finish lines were staffed with masked volunteers and long finishing chutes and chip timed so that finishers just kept moving through the finish to their respective team areas.
- no awards ceremony for congregation purposes, awards just picked up by winning team/athletes.
- multiple waves - limiting varsity wave to 7-10 runners per team and limit to 40 teams; then JV done the same. With the big meet we attended, they did three waves - and ordered them by entry time so that the fastest 50 kids were spread out in wave 1, then 50 next fastest in wave 2, etc.
- tent area for teams were marked for spacing and masks required if social distancing couldn't be accomplished.

There is a lot of science now on many of these sports and closing facilities just because it feels like the conservative thing to do should be reevaluated based on science.

Speaking for ourselves, we would absolutely volunteer in any capacity requested of the Leon County school district. We recommend this consideration only because we all acknowledge the hard and arduous work you all are undertaking in other areas and want to offer any support we can offer in making the process easier and more easily digestible as information and circumstances change week to week.”

I would like to urge you to consider opening your high school athletic competitions to outside teams such as ours. The highlights of our season for so many years now always include racing at Apalachee Regional Park. As a top national running program, we race at many venues throughout the state and around the country and truth be told there is no venue like yours. I can't think of a better venue right now during these times to more safely compete at than yours. The amount of careful investment in that Leon County property has led to the creation of a magnificent cross country race venue and it deserves to be constantly showcased. It is truly special and one of a kind for the youth running community. I am concerned that if there is a temporary restriction for using the Apalachee Cross Country venue this Fall that a long term agreement may be struck by the FHSAA with an alternative venue possibly more central to the rest of Florida. I am the parent of a high school cross country runner and very disappointed in the shortsighted decisions made by Leon County officials - decisions that prevent our high school cross country teams from leaving the county to compete in meets, while at the same time do not provide access to any resources for them to compete within Leon County.

As you may be aware, a decision was made by the Leon County Athletic Director to require all fall athletes to only compete in county. While this decision may be reasonable for fall sports that have access to facilities (like football and volleyball), cross country is in a very different situation. With this decision, in order for our Leon County high school cross country teams to have any kind of season, the teams must have access to County Parks (if they are not permitted to travel outside of the County). Since the County Parks are closed for any organized outdoor sports and athletic events, the decision made by the Leon County Athletic Director provides our high school cross country runners with no season.

Please do not penalize our student cross country athletes for living in Tallahassee. Please make an exception to the current closures of County Parks for organized athletic events that would allow our Leon County high school athletes to use County Park facilities.

To help you understand the importance of this request, please realize that cross country is not like swimming or many other sports where an athlete may enter state, regional or national tournaments – the chance to have times and make college recruitment and scholarship opportunities is only available to our kids in this short season - our kids need to be able to compete in official meets, and we need our County Parks to be available for use to do this. If our kids can't compete this season then their opportunities, and for many of them their college and life trajectories, irreparably will change. I have confirmed that other Florida counties have handled this in a more equitable manner -making sure that cross country athletes have access to trails/parks, or making exceptions that allow individual high school fall sport athletes to leave the county.

Running is not a simple hobby for many high school cross country athletes. My child, like many other runner athletes, has made sacrifices to train long hours while achieving a high GPA in school to achieve future goals of college cross country scholarships or to earn a spot on college cross country teams. Many cross country athletes across all of our Leon County schools have been up in the early morning hours and training six days a week consistently since their track season was canceled in mid-March. They have been 'unofficially' and successfully doing this TOGETHER during this entire time frame with NO incident. I have witnessed their discipline and determination to be ready for their fall season as they trained and led healthy lifestyles, taking every precaution to stay clear of COVID-19. Even when a couple of athletes on various teams were COVID positive, having contracted it through work or family in the cases of which I am aware, it did NOT spread to other teammates or those they were training with. We have several months of data now available to us – cross country is not a high risk sport. Also please know that the early Sports Medicine Advisory Committee (SMAC) report from FHSAA acknowledged the low risks associated with cross country. In fact, the SMAC recommended to allow cross country (as well as swimming and golf) to maintain the current FHSAA calendar with safety measures in place (masking while not running, and staggered starts at meets).

It is ironic that at this time in Leon County, cross country - confirmed to be one of the lowest risk sports - is the fall high school sport that is not being provided with any season. The decisions that have been made in Leon County regarding high school athletics do not appear to be in line with research and science.

Thank you for allowing this forum. With regard to the opening of Leon County Parks, specifically for the purpose of restarting youth sports in the wake of the pandemic, I ask that you carefully weigh the following positives, when considering what is potentially a far-reaching decision.

- By denying the opportunity of youth and high school sports to be played on our outstanding facilities, we are jeopardizing the physical and mental health and well-being of the next generation. The physical benefits are obvious, and it should be pointed out that the risk of contracting the COVID-19 virus in this age group are significantly reduced. However, the mental health of our youth is an issue that does not get addressed nearly enough. In many cases your decision will impact a group that has endured six-plus months of isolation and inactivity.
- Being a member of a team has benefits far greater than wins and losses. Learning to work together – across races, religions, and a multitude of other differences – has never been more important in our country. Not having an outlet for that to take place could further impact our community and country as these young people represent our future.
- Given the wealth of athletic talent in our community, opportunities for college scholarships (or building toward that) may well be denied without the opportunity to compete. Many, nearing the conclusion of their high school careers, have already lost a spring season as a result of the pandemic. Some, especially those in the year-round, distance-running events, will be severely impacted without the chance to compete in cross country this fall on our elite local facilities.
- I would be remiss in not pointing out that many of our local youth have been competing outside the area with their respective club teams, as other counties have been open throughout the summer for travel baseball, softball and soccer. Our children are leaving every weekend and returning to their normal activities now that the schools have been open. And it should be noted that our school-age positive COVID results have been minimal.
- By closing our parks to competition we have further hindered our local economy as it relates to heads-in-beds and businesses (restaurants, retailers), while other counties are reaping the benefits of open facilities.
- Leon County’s parks are second-to-none as a result of the commitment this county has made to not only take care of its own, but turn the Tallahassee area into viable destination for sporting events of all types. It is why Apalachee Regional Park – thanks to your substantial investment and the outstanding work of Visit Tallahassee – has been the long-time home to the Florida High School Athletic Association State Cross Country Championships, will host the 2020 AAU National Cross Country Championships in December and the 2021 NCAA Cross Country Championships in November of next year. Those are all contracted events, just like the 2020 FHSAA State Football Championships at Cox Stadium. If we are unable to host those events this year, we run the risk of losing perhaps the most significant financial niche our community has outside of Florida State University and Florida A&M athletics.

Thank you for your dedication to the best interest of the citizens of Leon county. Phases of re-opening based on verified data seem very reasonable. Currently, Leon county is in “phase 2” of the reopening plan, which means no recreational events are permitted. Recreational events may resume in phase 3. LCSS Athletic Department has implemented a precaution that will help allow high school athletics to resume. Leon County School District teams are permitted to compete in only local events held in Leon county. This eliminates the risk of athletes, parents, or coaches accidentally contracting the virus while traveling. Leon County is fortunate to have many athletic sites within its boundaries. We have the Phipps Property/Miller Landing Road trails, the Miccosukee and Alford Greenways, Tom Brown Park, and Piney Z, just to name a few running locations. There are top-notch swimming and golf facilities as well. Further, each of the activities of cross country, swimming, and golf can be modified to be contested in limited groups. Electronic timing and scoring systems eliminate the need for all athletes to “start” at the same time.

But these mitigating factors are not being implemented, and these enviable local facilities and locations are not being used for high school athletics, because recreational events cannot be held while still in phase 2. Impeding integral athletic achievements by classifying high school cross country, swimming, and golf as “recreational” seems unfair to the student athletes who have worked so hard for the past seven or more years to get to their senior year of competition.

We need Leon County to allow our athletes to use these facilities for athletic competitions for athletes only, not recreational events open to the public. Many sports are conducted by individual efforts aggregated into team scores. In other words, in cross country, golf, and swimming, all of the athletes do not need to be on or in the field/course/pool at the same time. Waves or heats of athletes can compete over a period of time to avoid the congregation of either athletes/coaches or parents/spectators. As the parent of a senior athlete who has state level ambitions, I would gladly forfeit watching her compete if eliminating spectators makes the difference between having a season or not. Please consider how hard this year’s seniors have worked to make it to this season, the culmination of their prep school athletic endeavors.

Leon County Schools System Athletics made accommodations for the more dangerous high school contact sports and have not made any recent progress with getting the less hazardous to be transmitted COVID19 sports running. We need your help to get cross country, golf, and swimming going ASAP! These non contact sports are far less likely to transmit the virus with social distancing guidelines in place for them to compete than the already scheduled contact sports. My daughter's Senior year at Leon High School is already a full-blown disaster because of the LCSS 's temporary competitive rules. Lilli Unger has worked hard for seven years @ Raa MS & Leon HS to finally be able to lead her team to the FHSAA 3A State Finals as the pre-season #1 ranked ladies team in the state of Florida. Almost all other Florida counties are already holding meets that will put our athletes behind in their athletic quests.

Please allow our athletes to compete in at least one of the county parks.

We have already been to Jacksonville for a pre-season meet held with social distance guidelines in place on August 21, 2020 and NO COVID 19 cases have been linked to any cross country meets. Our tests have all come back negative from that August experience.

I was tested because I donate my time as a volunteer mentor cross country & track & field coach at Raa MS for 7 years now. I wanted to make sure I wasn't an asymptomatic carrier before I engaged the team today, We only have 6 children signed up now to run when we would normally have 40-50. When we do open the parks for running competitions, we will not have huge crowds because of so many folks already being fully withdrawn from any of the sports options currently available at Leon County schools.

LCSS Athletics has implemented a precaution that will help allow high school athletics to resume. Leon County School District teams are permitted to compete in only local events held in Leon county. This eliminates the risk of athletes, parents, or coaches accidentally contracting the virus while traveling. Leon County is fortunate to have many athletic sites within its boundaries. We have the Phipps Property/Miller Landing Road trails, the Miccosukee and Alford Greenways, Tom Brown Park, and Piney Z, just to name a few running locations. There are top-notch swimming and golf facilities as well. Further, each of the activities of cross county, swimming, and golf can be modified to be contested in limited groups. Electronic timing and scoring systems eliminate the need for all athletes to "start" at the same time.

But these mitigating factors are not being implemented, and these enviable local facilities and locations are not being used for high school athletics, because recreational events cannot be held while still in phase 2. Impeding integral athletic achievements by classifying high school cross country, swimming, and golf as "recreational" seems unfair to the student athletes who have worked so hard for the past seven or more years to get to their senior year of competition.

We need Leon County to allow our athletes to use these facilities for athletic competitions for athletes only, not recreational events open to the public. As the parent of a senior athlete who has state level ambitions, I would gladly forfeit watching her compete if eliminating spectators makes the difference between having a season or not. Please consider how hard this year's seniors have worked to make it to this season, the culmination of their prep school athletic endeavors.

We have been advocating that the Commission authorize the use of real-time virtual public comment at all Commission meetings, workshops, and hearings in numerous comments we have provided since the Commission began to meet virtually in March of 2020 pursuant to Executive Order 20-69, suspending the requirement for a physical quorum and allowing the use of communications media technology (CMT) for meetings. As you likely know, in addition to numerous local governments in Florida, the City of Tallahassee is now providing this option at their meetings.

Real-time public comment and the possibility of commissioners asking questions during a meeting are critical to good decision-making. It is important that our elected policy-setting officials make public policy with meaningful public participation. This means that at a minimum, opportunities for public engagement and comment should be well publicized, easily accessible and transparent. In addition, public comments submitted in writing or in real-time should be reviewed and evaluated by all commissioners prior to making decisions. In fact, if a citizen takes the time to submit a written comment it is only fair that they receive some acknowledgement from our elected officials in return. The Commission should take every step to ensure that it is easy and safe for citizens to provide real-time feedback by providing an option for real-time virtual public comment at all Commission meetings going forward.

In Summary, please vote in favor of a revised Option #2 for Agenda Item #28 on the County Commission’s September 15, 2020 meeting. Option #2 is to modify the current procedure to allow for real-time citizen participation on all agenda items beginning with the September 29, 2020 meeting. In addition, please include in the motion to approve Option #2 direction to staff to revise the Commission’s Rules of Procedure for Meetings of the Leon County BOCC (Policy No. 01-05) to include a requirement with corresponding procedures for virtual real-time public comment at all future Commission meetings going forward, even after it is safe to attend in-person meetings and Executive Order No. 20-193, or its successor, expires.

When the Legislature enacted this language in 2013 (Senate Bill 50), it clearly intended that local governments allow citizens to speak and be heard, not to write and be read. Written comments don't count! That's why you should comply with the law and allow the public to speak and be heard during ALL meetings, including public hearings.

The chamber was full, the citizens were engaged and the commissioners were listening and responding. That is what democracy looks and sounds like. When we left that meeting, I reminded my wife that this was what KIR had to do when the Welaunee Arch issue came up the following month—activate our members and pack the house.

Sadly, the COVID virus changed all of that. Virtual meetings became the standard for both the City and County, and the public comment was taken out of the mix. Granted, citizens were allowed and encouraged to send their comments for the public record, and we were assured that the officials would read them all. But that is not the same as officials facing the public in real time. When that happens not only are fellow citizens and the press tuning in and listening, but the commissioners, facing their public detractors and supporters, are more apt to discuss, explain, defend and fully debate the issues in real time with each other on camera in the public arena. That's what democracy looks like.

Last week the City of Tallahassee began allowing public comments. The result was a fascinating and dynamic interchange that allowed citizens and public officials to work together to address problems and concerns in our community regarding city policing issues as well as the Welaunee Master Plan. As a result of that meeting, their commission voted 5-0 to slow down the process for the Welaunee Master Plan so both commissions, the staff and the public could work together to fine tune this massive project. City and Police Officials and Citizens also began to attempt to mend the broken fences stemming from the police intervention at a recent Black Lives Matter protest.

For democracy to work, it's important for public officials to remember that they are elected to do the public's bidding. The charrettes for the Welaunee Arch were a step in the right direction. Hopefully, each City and County Commissioner will take the time to listen to these sessions before the proposed workshop on October 14th. The key to having a workable and enforceable Master Plan is having our elected officials involved with the well informed decision making by listening and interacting in good faith with both staff and citizens.
