Propose that the county create an agenda item to add or change the appropriate zoning regulations as necessary to accommodate tiny houses, even in "mixed" neighborhoods with other larger houses.

Although there are several 4-13-2021 meeting agenda items relating to zoning, I do not know where on such a meeting agenda my request would fall. I believe my proposal would be more of a consensus/discussive item that I would like the LC Commission members to discuss, with an eye to ultimately changing the zoning restrictions for smaller houses. This proposal of mine could also be an agenda item of a future meeting.

Our world is shrinking--more people, less available acreage/space, dwindling resources (including food and housing)--and this calls for a logical and progressive policy and philosophy of "less is more." The era of oversized houses in certain areas of the United States (living space of 2000 sq ft or more for 1 to 3 persons) is beginning to be challenged by smaller living solutions in which shrinking planetary space and resources are taken into account, allowing more families to be able to afford to build a livable house that more readily suits their needs.

I am always surprised when I look at the Leon County Property Appraiser website and see the jumble of new abbreviated zoning labels that are added quite frequently. Certainly a city like Tallahassee and a county like Leon, both so richly diverse in other ways, can and should accommodate much smaller houses in the neighborhood mixes that currently exist. A house of 400 sq ft would still require the usual building permits, sewer and water hookup fees, etc., and would be required to pay similar taxes and other required fees to the appropriate government entity(ies). Moreover, private land ownership in the presence of discrete subdivisions should be allowed for all the reasons stated above.

I for one have lived in rental housing for several years but now that I am older, I would like to have my own place and build a tiny house so that I may enjoy a small yard for gardening. A tiny house would require less energy and fewer funds to keep up and maintain in a visually pleasing way.

I fully welcome your feedback on how to mold this idea of mine into a viable meeting agenda item and would also welcome the involvement of any LC Commission member(s) who may be interested in exploring this issue in greater depth.

As a long time resident of the Town & Country neighborhood near North Monroe Street, I strongly encourage you to approve formation of the N. Monroe St. Task Force to address a suite of issues in this area. The recent increase in crime threatens nearby homeowners, businesses and vulnerable homeless individuals. It also decreases property values, when often that is the single largest investment for many homeowners, and so they (myself included) can ill afford for that investment to be devalued due to the deterioration of the nearby area.

This area offers easy access to downtown, midtown, I-10 and the campuses at FSU & FAMU, as well as established neighborhoods with lovely trees and affordable homes. North Monroe Street is also one of the major gateways into our state's capital city, yet it makes a poor impression on visitors. This undermines efforts to position Tallahassee as a destination city and attractive option for new businesses - initiatives in which local government has made significant investments.

I have observed the time and resources put into improving the south side, downtown, midtown, northeast Tallahassee and elsewhere over the past 5-10 years and support those efforts. However, it seems that the northwest area is too often ignored, despite having much to offer. This task force is a critical first step towards identifying needed solutions. I have lived on Dellview Drive for 25 years, and I can see N Monroe Street from my front door. The area has changed drastically in the last two years, especially 2020. I no longer feel safe, and have stopped jogging or walking in my neighborhood. I keep my doors locked, even my gates to my backyard. People have come to my door and asked for money, and I've seen them digging through my trash bins when I set them out on collection day. It seems like the businesses I go to - Circle K on Sharer Rd, Publix, fast food restaurants, even the Centre of Tallahassee - everywhere I go people come up and ask for money. I think Tallahassee needs an ordinance prohibiting panhandling. The homeless people hang out all day AND leave a lot of litter (and I've seen them urinating on the sides/rear of businesses.

I am in favor of the Citizens' North Monroe Corridor Task Force. As the 'gateway' first impression of Tallahassee, North Monroe is a blight. As a primary traffic corridor for residents in the area, North Monroe can be a visual and safety affront. The increase in numbers of vagrants, homeless and others loitering at intersections makes North Monroe a safety concern for all. This last item appears to have improved since the re-opening of the Kearney Center.

Improvement suggestions: More control of signage style and size, landscaping in medians and between businesses and the street, sidewalks on the west side of Monroe south of Lakeshore Drive, enhanced transit stop design with better overhead protection from the elements, regular patrolling by sheriff and/or police, at intersections/locations where transient persons hang out, to discourage loitering and reduce the potential for crime.

Also, I am very concerned about neighborhood safety, because in early March, we had a middle of the night trespasser, presumably on drugs, on our premises in a quiet residential neighborhood. He knocked on a door at the end of our long driveway, asking for money and odd jobs. (Our house is approximately 1.5 miles from North Monroe and Lakeshore Drive, and is quite a hike in the dark at 1:30 a.m.) He left with no further incident.

3. WE CAN'T MOVE OUR BUSINESSES. WE HAVE A LARGE INVESTMENT BASED MOSTLY ON THE LOCATION. IF THE LOCATION GOES DOWNHILL THEN SO DOES OUR BUSINESS REGARDLESS OF THE JOB WE ARE DOING.

NOT BEING ABLE TO SOLVE THE PROBLEM OURSELVES IS VERY FRUSTRATING.

TO FIND OUT THE POLICE CANNOT DO ANYTHING ABOUT THIS IS AGGRAVATING. OUR PROPERTY IS RESPONSIBLE FOR \$500000 A YEAR IN TAXES AND FEES FOR THE COUNTY/CITY. WHEN WE BUILT THIS BUILDING WE DID EVERYTHING THE CITY AND COUNTY REQUIRED. I FELT AT THAT TIME WE SHOOKS HANDS WITH THE COUNTY AGREEING TO DO OUR PART. IT FEELS THAT THE COUNTY ISN'T UPHOLDING IT'S END OF THE DEAL TO PROTECT MY PROPERTY.
