### **County Offers Local Summer Youth Employment Opportunity**

Leon County announces the 11th Annual Summer Youth Training Program, designed to allow students to obtain work experience in a real-world environment. For six weeks, participants between the ages of 14 and 21 will be introduced to the workplace, gain valuable employment skills and earn a modest summer income.



Summer youth workers have the opportunity to gain experience in a variety of locations throughout Leon County, including Public Works, EMS, Parks & Recreation and other departments and divisions. There are 57 openings available, and positions will range from 18 to 25 hours per week and pay \$7.25 per hour.

The 2011 Summer Youth Training Program is scheduled to run from Monday, June 13, through Thursday, July 21, 2011. The application window opens on Monday, April 11, at 8 a.m. and closes Friday, May 6, at 5 p.m.

#### Leon County Hosts Town Hall Meeting for Southern Strategy Area

The Town Hall Meeting on the Southern Strategy Area, previously scheduled for Thursday, April 7, will now take place at 6 p.m. on Tuesday, April 19, in Building 2 at the North Florida Fairgrounds. There will be a presentation by the Tallahassee-Leon County Planning Department regarding schools, neighborhoods, housing, infrastructure, transportation, sewer, safety, the environment and economic development.

A component of this town hall meeting will be dedicated to a panel discussion addressing issues about the community. Invitations have been extended to representatives from the Southside Business Association, the Capital City Chamber of Commerce, Enterprise Zone Development Agency, the Knight Creative Communities Initiative, the Leon County School Board, and Florida Agricultural & Mechanical University. Dinner will be provided.

The Southern Strategy Area covers about 17  $\frac{1}{2}$  square miles, or nearly 11 percent of the area inside the Urban Service Area boundary, roughly from Cascade Park to Capital Circle and from Pensacola Street to north of Lake Munson.
