### **New Emergency Mobile** Animal Shelter Trailer



During the many past storms that affected the Big Bend area, evacuees retreated to Leon County for safety. Those who went to the Red Cross Shelter could not leave their pets as the shelters were not equipped to handle the four-legged evacuees.

Now there is a place for the animals. Leon County BOCC approved the purchase of an Emergency Mobile Animal Shelter Trailer, which can be transported to any Red Cross shelter in Leon County. The trailer is a self-contained unit with running water, sink, waste tank, air conditioning and heat, kennels and generator. The trailer is divided into two rooms to separate dogs from cats and is capable of holding up to 50 animals, depending on the configuration. The trailer can receive its power by either a generator, ground power or the transport vehicle.



Leon County broke ground on May 25, 2010 to begin its expansion to the existing Northeast Branch Library, which receives more than 15,000 visitors each month.
