Leon County Library Spring/Summer Events

The Third Annual Tallahassee Downtown Book Fair will take place Saturday, May 7, 2011, from 9:30 a.m. to 2 p.m. in Ponce de Leon Park (between Adams and North Monroe). The LeRoy Collins Leon County Library System and the Tallahassee Downtown Improvement Authority are sponsoring this free event for the public.

Adrian Fogelin, a young reader favorite and two-time Gold Medal Florida Book Award winner, is the featured author. Fogelin's books have universal appeal and are published internationally. Fogelin will take young readers behind the scenes of their favorite reads.

Katty Kay, Washington correspondent for the British Broadcasting Corporation (BBC), who provides the international perspective on American policy, politics and debate, will be the headline speaker at 1 p.m. She is the co-author, along with Claire Shipman, of "Womenomics: Write your Own Rules for Success: How to stop Juggling and Struggling and Finally Start Living and Working the Way You Really Want."

Come and meet local writers and authors. Tallahassee has a vibrant nexus of writers, and the Book Fair helps make the community aware of local talent. Authors will have their books available for purchase, and there will be something for everyone.

The Library's Summer Reading Program, "One World, Many Stories," will also be kicked off at the Book Fair, where young readers can pick up their personal reading record, bookmarks and stickers.

The Friends of the Library will be selling gently used books at great prices, and visitors can take advantage of the Library's bookmobile, which is making a special stop at the Book Fair.

Community Meeting or Proposed Commission Redistricting Map

The County will hold a community meeting on Thursday, May 26, at 6 p.m. at the Leon County Public Works Department, 2280 Miccosukee Road, to discuss proposed changes to the County Commission District Map. Leon County has five commission districts, which are required to be assessed every 10 years for any changes following the release of the U.S. Census data.

The proposed changes for 2011 are minimal and impact only a very small population of Leon County residents. Additionally, the proposed map maintains a minority-majority district and a minority-access district as required by U.S. District Court. It is also important to note that the proposed County Commission district map does not impact the Leon County School Board Districts. The School Board process is currently being conducted by Leon County Schools, independently from the County Commission. The County Commission is scheduled to consider the proposed map during a public hearing in June 2011. Prior to the public hearing, County officials would like to hear from citizens on the proposed map and any other concerns regarding the redistricting process.
