### **Electronics, Household Hazardous** Waste Collection Announced

Leon County announces the next monthly Household Hazardous Waste & Electronics Collection, which will take place on Saturday, Sept. 4, from 9 a.m. to 1 p.m. at the Public Works Operations Center, 2280 Miccosukee Road.

When discarded, many household products can pollute and pose a health risk, so Leon County holds these free events for Leon County residents. Businesses and other agencies must call (850) 606-1816 to make an appointment to drop off their items. Some fees will apply.

Citizens may bring up to 50 lbs. of hazardous waste, in addition to their electronics. Propane tanks must weigh less than 40 lbs., and there is a limit of one tire per participant. Medical sharps, medicines and radioactive waste cannot be accepted.

The Leon County Hazardous Waste Center, located at 7550 Apalachee Pkwy., is open Monday through Saturday, from 8 a.m. to 5 p.m.

## **County Receives State Grant for Miccosukee** Canopy Road Greenways

Leon County Parks & Recreation Division received notice from the State Office of Greenways and Trails that it will be receiving a \$250,000 grant from the Recreational Trails Program to match \$250,000 of County funds for trail renovations of Miccosukee Canopy Road Greenways. The funds will provide for upgrading the trail system from Thornton Road Trailhead to Crump Road Trailhead. With this grant, an all-weather trail will extend from Edenfield to Crump Road Trailhead.

# New Agricultural Container **Recycling For Leon County**

Leon County has teamed up with the Agricultural Container Recycling Council to provide a recycling service for commercial and agricultural chemical containers.

Containers must be plastic, dry and properly triple-rinsed to be accepted. The service will be free to Leon County commercial applicators. This program doe farmers and not currently include household products.

### **County Receives Land from** Florida Gas Transmission

Leon County held a Property Donation Ceremony on Wednesday, Aug. 11, to announce a donation of land from the Florida Gas Transmission (FGT) Company to mitigate the impacts of the construction of a new gas line.



FGT is constructing a gas transmission expansion project that includes approximately 26 miles of new pipeline across Leon County. The donation consists of roughly 132 acres of land, including wetlands and floodplains. Any construction on the already environmentally sensitive area could potentially have been damaging, so development rights were eliminated upon the County's acquisition in order to protect the land.

The disturbance to the land will be limited to the trenching necessary to bury the pipe, which will be approximately six-feet-deep. After the pipe is buried, there will be a new permanently mowed area 25 feet in width, and the other areas will be brought back to pre-existing conditions and allowed to develop naturally.

Rick Craig, Vice President of Phase VIII Project Management for the Florida Gas Transmission Company, also spoke at the event and expressed his appreciation for the County's partnership throughout the transfer.
